AustCham has recently met with a wide-range of government representatives from China's Central Government, Hong Kong Government, Australian Federal and State Governments. This engagement is aimed at ensuring that governments understand the importance of Hong Kong for international business, the importance of the Hong Kong-Australia business, trade and investment relationship, and our members' interests and concerns. Where those meetings are part of a broader event, they also provide a platform for members to better connect with government programs and understand government support available for business.

We look forward to continuing this representation into March with a **Private Briefing with Australia's Ambassador to China**, Scott Dewar, upon the occasion of his first visit as Ambassador to Hong Kong. With recent developments on the Australia-China relationship, including an invitation to the Chinses Foreign Minister Wang Yi to visit Australia, the Briefing provides a timely opportunity to hear directly from Australia's most senior representative. All members are invited to join the Briefing and can register here.

Our work on Australian tax advocacy continues with a submission to the Hong Kong Government supporting Australia as a potential Comprehensive Double Tax Agreement partner with Hong Kong. A copy of our submission can be found online here.

AustCham is also continuing its industry-led advocacy work through our Construction, Property and Infrastructure Committee with the release of the findings from our Decarbonising Hong Kong's Built Environment Conference. On 27 March we will launch the **Net Zero Playbook**, developed in collaboration with Knowledge Partner Savills and consolidating insights from more than a dozen leading international, regional and local experts. The Playbook provides a strong direction for Hong Kong's net zero future. - What are the meaningful next steps?


The Playbook includes recommendations for government, industry and built environment investors to accelerate Hong Kong's decarbonisation and net zero ambitions.
